Insurance

The amount of the premium is determined by the declared value of the goods rounded to full EUR 1,000.00 as well as the type of services.

BASIC CONDITIONS OF CONTRACT

The contract forwarding agent operates exclusively in accordance with the latest version of the Allgemeinen Deutschen Spediteurbedingungen - ADSp - (German Freight Forwarders' General Terms and Conditions). These limit in clause 23 ADSp the legal liability for damage to goods according to Art. 431 of the German Commercial Code (HGB) in case of damage to goods whilst in the care of a forwarder to € 5/kg, in case of multimodal transports including sea transport to 2 SDR/kg and in addition to € 1 Million per damage respectively to € 2 Million per event or 2 SDR/kg whichever is the greater. The parties agree subsidiary, that (1) clause 27 ADSp does neither extend the liability nor the responsibility of the forwarder for agents, servants, employees or crewmembers beyond legal regulations as Art. 507 HGB, Art. 25 MC, Art. 36 CIM, Art. 20, 21 CMNI for the benefit of the principal, (2) the freight forwarder as a sea carrier is only liable for fault of his own part in case of risks provided in Art. 512 paragraph 2 no. 1 HGB (default in navigation of the ship or fire on board) and (3) the freight forwarder as a carrier defined in CMNI is relieved of liability for default in navigation of the ship, fire on board or defects of vessel under the conditions mentioned in Art. 25 paragraph 2 CMNI. Unless mandatory provisions to the contrary (e.g. CMR, The Hague Rules, Montreal Agreement) are applicable. In case of transport, storage or other handling of objects of art, the latest version of the Standard Terms and Conditions Art (“GBT Art”) shall apply.

Inbound handling

Handling via external warehouse including receipt, short term storage and timely delivery to booth.

Outbound handling

Storage of empties

Handling of empty packing (Minimum 2 cbm)

 - Permanent customs clearance including customs inspection **EUR 150,00**

 - Temporary customs clearance including customs inspection **EUR 150,00**
 - Bond fee (0,5% on value) Minimum **EUR 35,00**
